Three Rivers Operating is requesting a 6 month extension of the TA status of this well. We would like to recompleat and place this well back into production in the near future. At present Rubicon has shut down the pipeline that well production flows to. Three Rivers is currently in negotiations to acquire the Rubicon pipeline. If this is not attainable then we will lay a pipeline approx. 5 miles long to tie into an El Paso pipeline. Permits for the pipeline ROW will have to be prepared and submitted for approval. The TA status will expire 2/3/2011 and we will require more time to get all issues addressed and approved.
