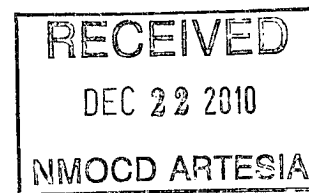

Perf Delaware B 4118-4124 (7 holes), 4129-4136 (8 holes). Set RBP @ 4185' and pkr @ 4089'. Acidize new perfs w/ 1700 gals 15% NEFE HCL and 300 gals Xylene. Frac w/ 20,122 gals 25% XL gel and 28,531# 16/30 SCL sand. Removed RBP and clean down to PBTD. TIH w/ 132 jts. 2 3/8" tbg. TAC @ 3967'. TIH w/ production equipment. Place well back on production.
