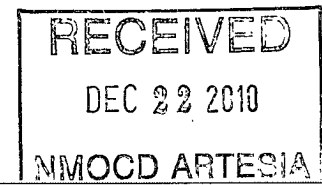

PDU 202 had perfs added in the Delaware A and B sands. Removed production equipment. RIH w/ pkr and Acidize exsiting perfs 4136-4220' w/ 7000 gals. of 15% Petrol. Set RBP @ 4088'. Spot 500 gals 15% NEFE HCL. Perf Delaware A and B 3956-3960' 1 SPF (4 holes), 3978-3982' 2 SPF (8 holes), 4020-4024' 1 SPF (4 holes), 4030-4035' 1 SPF (5 holes). Broke down new perfs w/ spot acid. Treated w/ 1500 gals 15% NEFE HCL. Frac new perfs w/ 26,460 gals of 25# XL gel and 49,512# SLC sand. Remove RBP. Clean out fill to 4500'. RIH w/ 130 jts. of 2 3/8" J55 tbg. Set TAC @ 3939' RIH w/ production equipment. Place well back on production.
