Cmted lead w/100 sx (163 cf) "C" cmt w/10 sx cal-seal, 10# gilsonite, 1% Cacl2, & 1/8#/sx p-e-flake, 225 sx (304 cf) "C" w/2% Cacl2 & 1/8# p-e flake. Tailed w/200 sx (270 cf) "C" cmt w/2% Cacl2. Circ 157 sx cmt to surface. On 11/8/10, PT 8-5/8" csg to 600 psi for 30 min - OK.

Drilled 7-7/8" hole to TD5106' on 11/21/10. Ran open hole logs. Landed 5-1/2" 17# J-55 csg @ 5089'. Cmted lead w/550 sx (1028 cf) 35/65 poz C cmt w/0.125#/sx p-e-flake, 3#/sx salt, 0.5% Halad-9, & 3#/sx gilsonite. Tailed w/650 sx (865 cf) "C" cmt w/0.125#/sx p-e-flake, 0.4% Lap-1, 0.5% CFR-3, & 1/4#/sx D-air. Circ 0 sx cmt to pit. Calc TOC @ 1200'. Released drilling rig on 11/22/10. Plan to pressure test the 5-1/2" csg before completion operations.

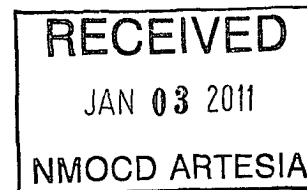
