3. RIH with 2-7/8 " tubing carrying 5-1/2" packer with tubing conveyed perforating system.
4. Set 5-1/2" pkr @ +/- 11,250' and perforate Atoka from 11,309' 11326' at 4 spf.
5. Return well to production with Atoka producing up 2-7/8" tubing.
