13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Premier Oil and Gas respectfully requests approval to change the intermediate hole size from 12-1/4" to 11". The 11" hole size is the standard hole size being used by most operators in the Loco Hills area. The proposed cement program is to cement to surface with 230 sx. Class "C" Lite (yield 1.91 cfps, density 12.7 ppg) lead slurry followed by 200 sx. Class "C" plus 2% CaCl2 (yield 1.32 cfps, density 14.8 ppg) tail slurry. These volumes assume 100% excess annular volume between the 13-3/8" casing shoe and TD at approximately 1300'.

*Based on hole with 350' of 13 3/8" casing,
excess cement calculates to 67%.*
