Spud well on 1/14/11. Drilled 12-1/4" hole to 446'. Landed 8-5/8" 24# J-55 csg @ 430'. Cmted lead w/175 sx (236 cf) "C" cmt w/2% Cacl2, & 1/4#/sx cello-flake. Tailed w/200 sx (264 cf) "C" cmt w/2% Cacl2. Circ 163 sx cmt to surface. On 1/16/11, PT 8-5/8" csg to 600 psi for 30 min - OK.

Drilled 7-7/8" hole to TD4766' on 1/27/11. Ran open hole logs. Landed 5-1/2" 17# J-55 csg @ 4749'. Cmted lead w/500 sx (950 cf) 35/65 poz C cmt w/0.125#/sx p-e-flake, 3#/sx salt, 0.5% Halad-9, & 3#/sx gilsonite. Tailed w/550 sx (732 cf) "C" cmt w/0.125#/sx p-e-flake, 0.4% Lap-1, 0.5% CFR-3, & 1/4#/sx D-air. Circ 132 sx cmt to pit. Released drilling rig on 1/28/11. Plan to pressure test the 5-1/2" csg before completion operations.
