Drill 10-5/8" hole to 4000'. RIH w/ 8-5/8 csg 32# J-55 LTC & set @ 4000', cmt w/ 1100sx (368bb1) PPC followed by 200sx (48bb1) PPC all w/ additives, circ 299sx (100bb1) cmt to surf, WOC, Test BOP's.

Drill 7-7/8" hole to 8690'M 8309'V. Log well, RIH w/ 5-1/2" 17# J55 LTC csg @ 8690' w/ DVT @ 5919', POST @ 4068'. Cmt 1st stage w/ 570sx (167bb1) Super H, circ 261sx (75bb1) cmt to surf. Cmt 2nd stage w/ 600sx (172bb1) Super H, circ 244sx (70bb1) cmt to surf. Cmt 3rd stage w/ 380sx (141bb1) PPC followed by 150sx (36bb1) PPC all w/ additives, circ 93sx (34bb1) cmt to surf. Rel Rig 1/21/11.
