Cmt 2nd stage w/ 730sx (209bbl) Super H, circ 313sx (90bbl) cmt to surf. Cmt 3rd stage w/ 370sx (135bbl) PPC followed by 150sx (36bbl) PPC all w/ additives, circ 246sx (90bbl) cmt to surf. Rel Rig 2/22/11.
