## Gentlemen:

Your letter, of August 31, 2010, describes the lands remaining in the Arley Federal Exploratory Unit "NM-109672X", Eddy County, New Mexico (Exhibit B) effective October 23, 2008, pursuant to Section 2(e) of the unit agreement and should request our concurrence. The lands you have described contain 318.44 acres, more or less, and constitute all legal subdivisions, and are in the Initial Upper Pennsylvanian Participating Area "NM-109672A". As a result of the automatic elimination, the unit area is reducing from 2,925.50 acres to 318.44 acres.
