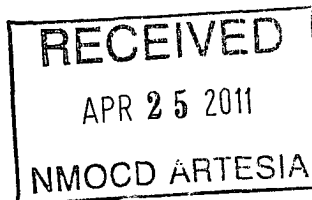
Mewbourne Oil Company has an approved APD for the above captioned well. After further review, the top of the San Andres formation is at 777'. We would like to change the casing program as follows:
