## **NOTICE OF VIOLATION and SHUT-IN DIRECTIVE Failed Mechanical Integrity Test**

Dear Operator:

The test(s) indicates that the well or wells failed to meet mechanical integrity standards of the New Mexico Oil Conservation Division. This determination is based on a test of your well or facility by an inspector employed by the Oil Conservation Division. "Failure Type" and "Failure Cause" and any Comments are not to be interpreted as a diagnosis of the condition of the wellbore. Additional testing should be conducted by the operator to accurately determine the nature of the actual failure. \* Significant Non-Compliance events are reported directly to the EPA, Region VI, Dallas, Texas.
