4. Perforate Premier Section 2,852' - 2,860'; 2,864' - 2,870'; and sand frac with 20,000 gals treated brine and 20,000 lbs. sand.
5. Circulate sand and clean to total depth 3,412'.
6. Place well back to pumping.
