On Nov. 15, 1978, cemented 8-5/8" O.D. 24# K-55 casing at 528' with 300 sacks class "C" cement + 2% CaCl. Cemented on outside of 8-5/8" with 8 yards redi-mix, filled to cellar.

On Nov. 21, 1978, cemented 4 1/2" O.D. 9.5# J-55 casing at 3559' with 200 sacks class "C" + .5% CFR-2 + 5# salt/sx. (1st stage). Opened DV tool at 2837' and circulated. On Nov. 24, 1978, cemented thru DV collar with 380 sx. class "H" + 10# salt/sx. + 50 sx. thickset cement with 2% CaCl. On Nov. 25, 1978, cemented thru DV collar with 200 sx. class "C" + 6% gel + 100 sx. class "C" + 3% CaCl. Closed DV collar. Top of cement behind 4 1/2" is at 1504'.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
