3. Acidize perfs 2908-2915 w/250 gals 15% NEA and frac'd w/10,000 gals gel brine wtr w/1# gal 20-40 sand. Second stage: Set RBP @ 2825' and packer @ 2750'. Acidized perfs 2797-2806 w/250 gals 15% NEA and frac'd w/10,000 gals gel brine wtr w/1# gal 20-40 sand. 1 hr SIP 1400#. Third stage: Set RBP @ 2610' and packer @ 2550'. Acidized perfs 2588-2596' w/250 gals 15% NEA and frac'd w/10,000 gals gel brine wtr w/1# gal 20-40 sand. Comp 6:45 P.M. 7-29-75.
4. Ran 2-3/8" OD tubing and set @ 3114'. Swab.
5. Ran pump equipment. Test and return to production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
