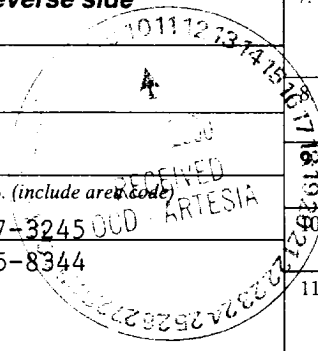

1. Pull rods, pump and tubing
2. Pump hole full of cement (½" rock transit mix)
3. Erect P&A marker and clean location
