13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. On 11/5/92, we set 8400' of 5 1/2" 15.5 and 17 ppf K-55 LT&C production casing in a 7 7/8" open hole. We cemented the production casing in two stages with a stage collar (DV tool) at 5781'. We pumped the following slurries:

1st Stage: 600 sks Silica Lite + 3% salt + 0.6% fluid loss additive + 1/4 lb/sk cellophane flakes (215 sks were circulated to surface)

2nd Stage: 400 sks 35:65 (Poz:Class H) + 6% gel + 1/4 lb/sk cellophane flakes followed by 100 sks Class C neat

Estimated top of cement = 2940'. The BLM (Mrs. Russell) was notified prior to running the casing and cementing. The rig was released at 11:30 a.m.
