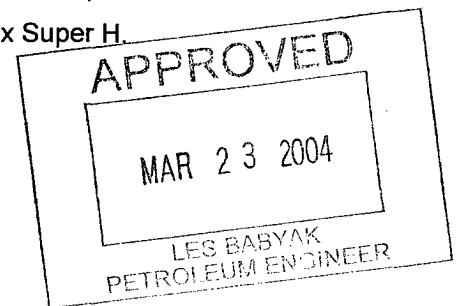

Set 26# HCP-110 7" casing at 8500' and cement to surface with 900 sx of interfill C and premium plus.

Set 13.5# HCP-110 4 1/2" liner with top at 8000' and bottom at 13000'. Cement with 160 sx Super H.
