This well is currently a shut-in producing well in the Tamano (BSSC) Unit. Plans are to recomplete to the 1st Bone Spring Sand which is outside the unitized interval.

Proposed work:

1. Set a CIBP @ 8000' & cap w/ 35' cmt.
2. Perforate Bone Spring 1st Sand 7557'-66', 7593'-602', 7616'-35', 1 spf, 40 holes.
3. Acidize w/ 1500 gal acid.
4. Frac w/ 40,000 gal + 70,000# 20/40.

* This well was originally drilled as the Johnson "B" Federal #7. Name was changed to Tamano (BSSC) Unit #407. This recompletion to the nonunitized interval requires name be changed back.
