BY WATER DISPOSAL AGREEMENT BETWEEN KERR MCGEE OIL & GAS ONSHORE LLC AND YATES PETROLEUM CORPORATION, IT IS AGREED UPON TO DISPOSE OF PRODUCED WATER FROM THE KERR MCGEE OIL & GAS ONSHORE LLC OPERATED WELLS AS FOLLOWS: FEDERAL 28-2, FEDERAL 28-3 & FEDERAL 28-4 UNDER LEASE # NM 022535 INTO THE BUNNELL FEDERAL #3 SWD WELL.

ALL WATER IS TO BE MEASURED AND ALLOCATED BACK TO THE WELL WHICH PRODUCED THE WATER ON A MONTHLY BASIS.

WATER STORAGE ON THE FEDERAL 28 LEASE IS 1000 BBLS CAPACITY. WATER IS PUMPED TO THE BUNNELL FEDERAL #3 WELL FOR DISPOSAL. AVERAGE DAILY AMOUNT OF WATER DISPOSED IS 1000 - 1100 BBLS.

FLOW OF WATER IS CONTROLLED BY HIGH LEVEL ALARMS AND SHUT DOWN INSTRUMENTS TO ELIMINATE ANY OVERFLOW OR SPILL AT THE FEDERAL 28 FACILITY.
