Mack Energy Corporation would like to change the surface hole size from 12 1/4 to 17 1/2. We will drill a 17 1/2 hole to +-300', if no problems are encountered we will then change to a 12 1/4 bit and drill to original depth of 1600' and run 8 5/8 casing. If we encounter hole problems we will set an optional 13 3/8 casing string at +-300' and circulate cement.
