Devon Energy respectfully requests permission to plug back the existing wellbore to approximately 5,700' by setting a CIBP at $\pm 7,350'$, circulating the wellbore with 9.0 ppg plug mud, capping the CIBP @ $\pm 7,350'$ with at least 35' of cement, setting another CIBP at $\pm 5,800'$, cutting off the casing at $\pm 5,700'$, and pumping a 100' in/out cement plug from $\pm 5,800'$ to $\pm 5,600'$. We will then use this in/out cement plug as a kick off point to directionally drill the new wellbore to the bottom hole location indicated above attempting to find commercially productive Morrow pay.
