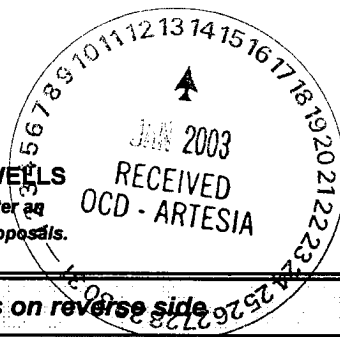

12/19/02 Drilled out composite at 5700'. Pushed to 5980'. Set ASI 2.25" packer at 5336'.

Well is now commingled Foor Ranch Pre-Permian (Strawn) with Northwest Foor Ranch Wolfcamp Gas (Wolfcamp).
