Devon Energy Production Company, LP respectfully requests approval to install a 2000# drilling head on the 13 3/8" casing. The BOP equipment will be rated to 30003. The BOP & associated wellhead equipment will be tested to 1215# with the rig pump. After setting the 9 5/8" casing, a 5000# casing head & 5000# BOP will be installed & tested with an independent tester in accordance with Onshore Order No. 2.

Devon additionally requests to change the casing depth on the 9 5/8" casing from 2400' to 2700' for additional well control.
