10/22/04 – Resumed drilling at 7:15 PM. TD 17-1/2" hole at 7:00 AM. Set 13-3/8" 48# H-40 ST&C casing at 427'. Cemented with 250 sx Class "C" + 2% CaCl₂ + 1/4#/sx Celloflake (yld 1.35, wt 14.8). Tailed in with 200 sx Class "C" + 2% CaCl₂ (yld 1.34, wt 14.8). Cement circulated to surface. WOC. Tested casing to 1000 psi for 30 mins, OK. WOC 20 hrs 15 mins. Reduced hole to 12-1/4" and resumed drilling.
