10/17/04 - Set 13-3/8" 48# casing at 604'. Cemented with 285 sx Halliburton Lite Premium Plus + 2% CaCl (yld 1.888, wt 12.7). Tailed in with 250 sx Premium Plus cement + 2% CaCl (yld 1.343, wt 14.8). Cement circulated to surface. Tested casing to 600 psi for 30 mins. OK. WOC 26 hrs 30 mins. Reduced hole to 11" and resumed drilling.
