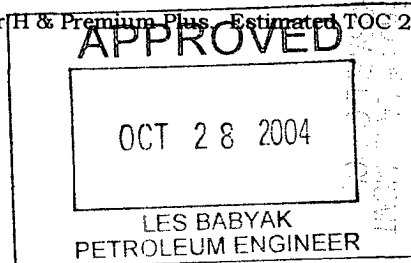

Set 13000' of 5 1/2" NS-110/HCP-110 17# casing. Cement with 1620 sx of Super H & Premium Plus. Estimated TOC 2700'
