MOC has set 13 3/8" casing at 336' and circulate cement to surface. Drilled out with 12 1/4" bit. Plan to drill to 3000' and run 9 5/8" casing. At 1920', lost all returns while drilling. Present operation is dry drilling. Would like to change 9 5/8" setting depth from 3000' to 2600'. Plan to run stage tool and external casing packer at 1800' and plan to circulate cement to surface.
