Tailed in with 200 sx Class "C" + 2% CaCl₂ (yld 1.34, wt 14.8). Cement did not circulate. WOC 6-1/2 hrs. Ran 1" cement to surface with 900 sx Class "C" + 6% CaCl₂. WOC 66 hrs. Reduced hole to 8-3/4" and resumed drilling.
