02/23/11 RIH w/ 207/8" prod tbg to land pkr @ 4391' FS. Circ wellbore w/ 100 bbls 2% KCl. Set pkr & test csg to 580 psi for 20 min (held OK).
02/24/11 Press csg to 600 psi for 30 min w/ tbg open to tank & 8-5/8" x 5-1/2" csg open. MIT witnessed by BLM Rep Paul Swartz. Pump 2500 gals Toluene followed w/ 1000 gals 7-1/2" HCl w/ additives, flush acid w/ 40 bbls 2% KCl. Clean location & return to injection.
