5/26/11 to 5/27/11 Set 2 7/8" J-55 tbg & pkr @ 6887'.

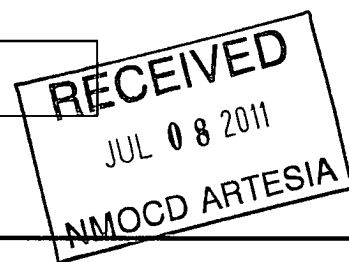
