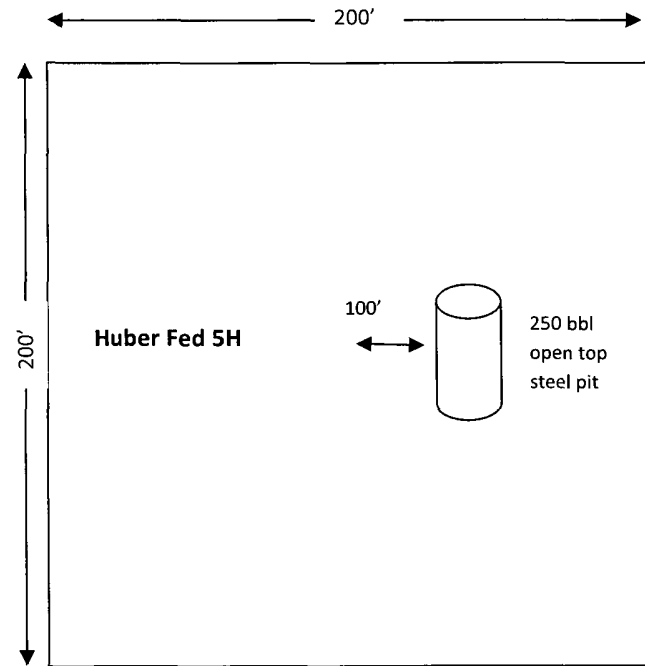
## **II Operations and Maintenance Plan**

The contaminated soil will either be remediated in-situ or be excavated and taken to an approved facility.
