THE APPLICATION OF A. H. RAINS FOR A SALT WATER DISPOSAL WELL!

ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701 (C), A. H. Rains made application to the New Mexico Oil Conservation Commission on December 13, 1976, for permission to complete for salt water disposal his Exxon State Well No. 8 located in Unit O of Section 15, Township 21 South, Range 27 East, NMPM, Lea County, New Mexico.

The Secretary-Director finds:

- l. That application has been duly filed under the provisions of Rule 701 (C) of the Commission Rules and Regulations:
- That satisfactory information has been provided that all offset operators and surface owners have been duly notified;
- 3. That the applicant has presented satisfactory evidence that all requirements in Rule 701 (C) will be met.
- 4. That no oubjections have been received within the waiting period prescribed by said rule.

IT IS FURTEER ORDERED:

That the applicant herein, A. H. Rains, is hereby authorized to complete its Exxon State Well No. 8 located in Unit O of Section 15, Township 21 South, Range 27 Fast, NMPM, Eddy County, New Mexico, in such a manner as to permit the injection of salt water for disposal purposes into the Yates formation at approximately 570 feet to approximately 600 feet through 2 3/8 inch plastic lined tubing set in a packer located at approximately 565 feet.

IT IS FURTHER ORDERED:

That the operator shall take all steps necessary to ensure that the injected water enters only the proposed injection interval and is not permitted to escape to other formations or onto the surface.

That the casing-tubing annulus shall be loaded with an inert fluid and equipped with a pressure gauge at the surface or left openuto the atmosphere to facilitate detection of leakage in the casing tubing, or packer.

That the operator shall notify the supervisor of the Commission's Artesia District Office before injection is commenced through said well.

That, the operator shall immediately notify the supervisor of the Commission's Artesia Office of the failure of the tubing, casing, or packer in said well or the leakage of water from or around said well and shall take such steps as may be timely or necessary to correct such failure or leakage.

PROVIDED FURTHER

That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order after notice and hearing the Commission may terminate the authority hereby granted in the interest of conservation. That applicant shall submit monthly reports of the disposal operation in accordance with Rule 704 and 1120 of the Commission Rules and Regulations.

Disposal of Produced Water From Federal Wells Conditions of Approval

Approval of the produced water disposal methodology is subject to the following conditions of approval:

- 1. This agency shall be notified of any change in your method or location of disposal.
- 2. Compliance with all provisions of Onshore Order No. 7.
- 3. This agency shall be notified of any spill or discharge as required by NTL-3A.
- 4. This agency reserves the right to modify or rescind approval whenever it determines continued use of the approved method may adversely affect the surface or subsurface environments.
- 5. All above ground structures on the lease shall be painted Shale Green (5Y 4/2), or as per approved APD stipulations. This is to be done within 90 days, if you have not already done so.
- Any on-lease open top storage tanks shall be covered with a protective cover to prevent entry by birds and other wildlife.
- 7. This approval should not constitute the granting of any right-of-way or construction rights not granted by the lease instrument.
- 8. If water is transported via a pipeline that extends beyond the lease boundary, then you need to submit within 30 days an application for right-of-way approval to the Realty Section in this office if you have not already done so.
- 9. Disposal at any other site will require prior approval.
- 10. Subject to like approval by NMOCD.
