Run 13.375 inch surface casing to 603 ft. Pump 40 bbls gel spacer, followed by 510 sks of 13.5 ppg lead cmt, 340 sks of 14.8 ppg tail cmt. Drop plug and displace with 91 bbls brine. 140 bbls returned to surface. Test casing to 1500 psi for 30 minutes, good test.
