- B. Based upon oil production of 6 barrels per day, the estimated \* volume  
of gas to be flared is 3 MCF; Value \$2 per day.
- C. Name and location of nearest gas gathering facility:

- D. Distance 2 miles Estimated cost of connection \$2,500,000
- E. This exception is requested for the following reasons: No economic gas pipeline connection has  
been discovered which will handle the H2S content. We are continuing to look for a gas sales option.  
In the mean time, we need to flare gas production to maintain the oil production.
