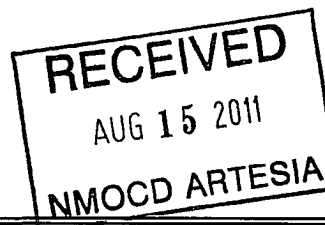

Tailed in with 165 sx Class "C" (yld 1.37, wt 14.8). Circulated 30 sx to pit. Tested casing to 250 psi low, 1500 psi high for 30 min. WOC 24 hrs 30 min. Reduced hole to 7-7/8" and resumed drilling.
