Production logs indicated that the majority of the water produced from this wellbore was entering through the bottom set of 3 perforations. A workover was performed from 2/28/05 through 3/11/05 in which a cast iron bridge plug with 2 sacks of cement was set with the top at 11,606' EL. Tubing was run back in the hole and packer was set at 10,318'.

Test after: 150 mcf/d, 6 bwpd
