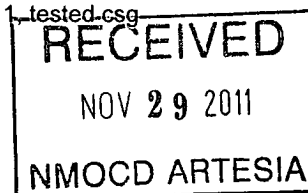

Mixed @ 15.6#/g w/1.19 yd. Plug down @ 9:30 PM 10/26/11. Circ 24 sks cement to pit. WOC 18 hrs. Tested "B" section pack-off to 2500#. Tested BOPE to 3000# & annular 1500#. At 10:45 AM 10/29/11, tested csg to 1500 for 30 mins, held OK. Drilled out with 6 1/8" bit.
