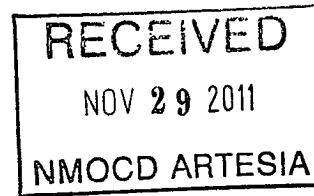

Mixed @ 14.8#/g w/1.34 yd. Plug down @ 11:00 AM 11/18/11. Circ 100 sks cement to pit. WOC 18 hrs. At 11:45 AM 11/19/11, tested BOPE & csg to 1500# for 30 mins, held OK. Drilled out with 6 1/8" bit.
