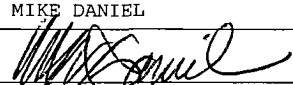

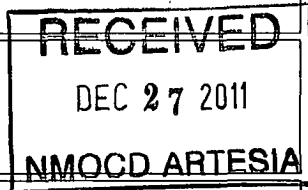

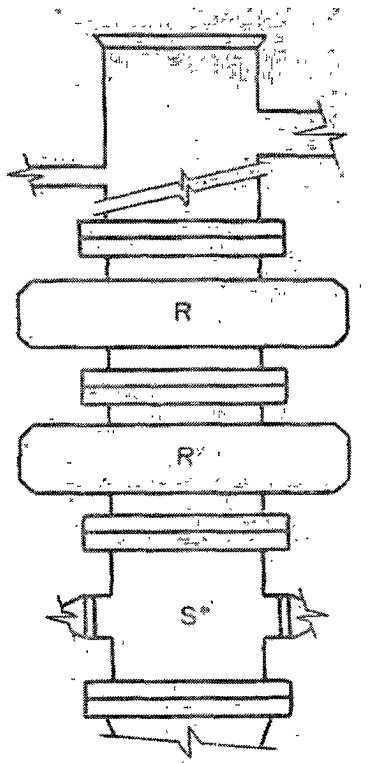

Empire 23 State # 1



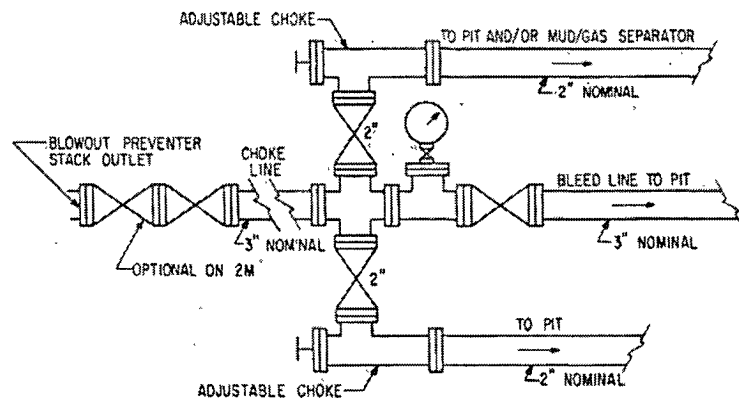
3000 PSI Working Pressure
