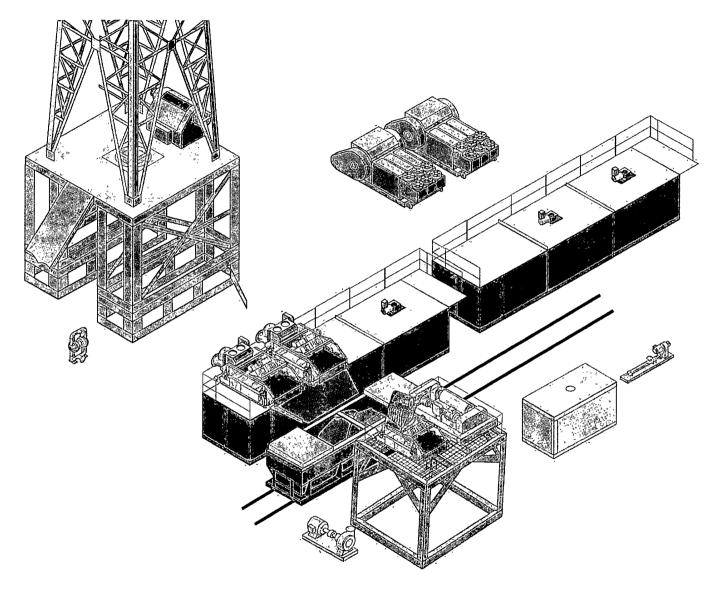
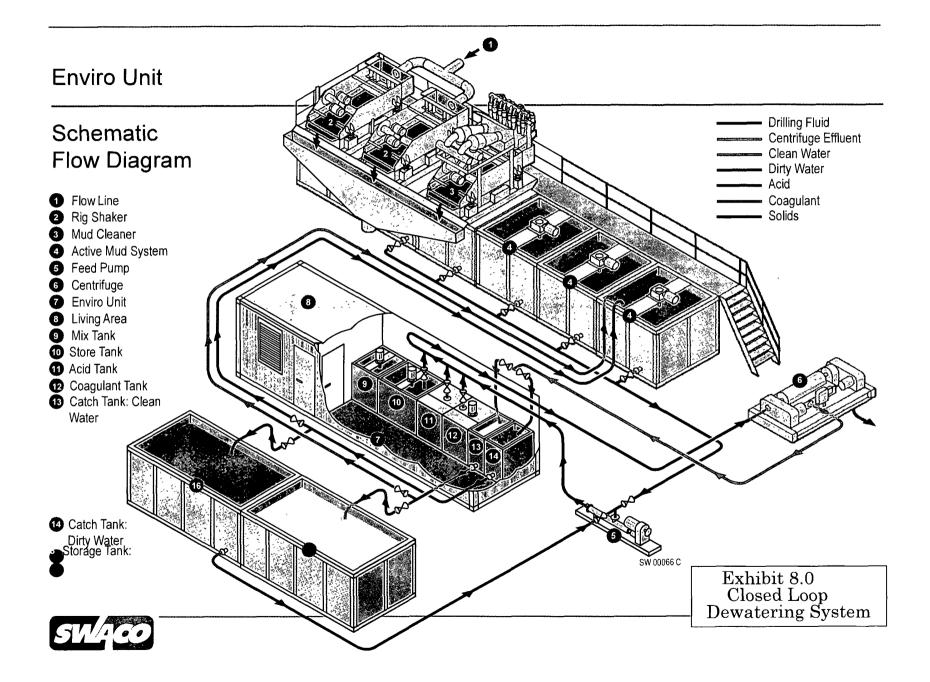
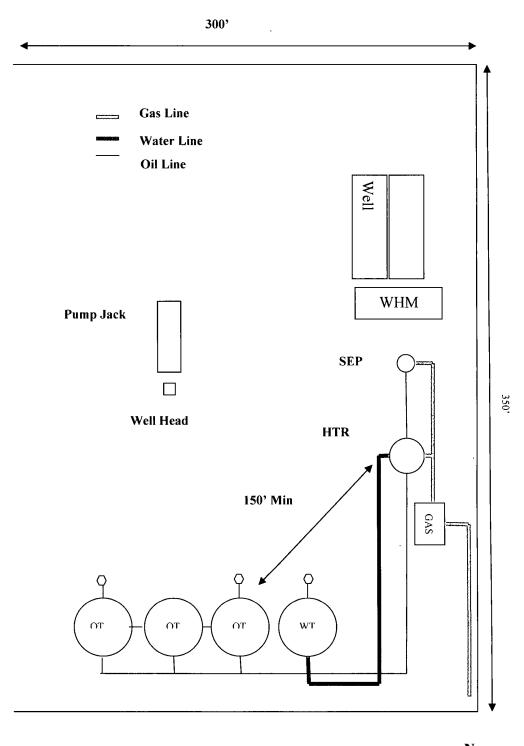


Exhibit 9 Closed Loop/Roll-Off Bins
