13 Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. 1. Talon/LPE mobilized to the location at the Carbon Valley Deep 23 Federal No. 1 on 9/7/2011, to begin blading the surface of the closed drilling pit. Rock and contaminated soil were deep buried into the drilling reserve pit.


2. A trench was excavated on the boundaries of the closed drilling pit area to three feet (3') below ground surface (bgs).

3. A 20 Mil. liner one hundred feet (126') long by two hundred feet (200') wide was installed over the closed drilling reserve pit area. The liner was keyed into the ground a minimum of three (3') feet bgs.

4. The Depco Federal No. 3 was downsized and the soil removed from that location was placed over the top of the 20 Mil. liner. New soil was transported in from a local borrow pit. A minimum of three 3-4 feet of new soil was placed over the top of the liner.

5 The soil lift was contoured to match the surrounding terrain and will be seeded using the recommended BLM seed mixture for the area.
