This well is due for the TA Extension to expire on 02/13/2012.

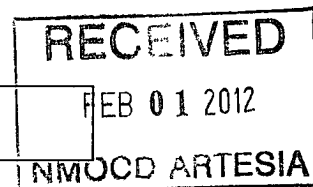
