11-30-11 POH and LD 58 jts plus 10' weld on, 5-1/2"-15.5#/FT J-55, 8RD csg. Spot 75 sx, plug @ 2972'. WOC

12-01-11 RIH, tag plug @ 2499', POH, spot 100 sx @ 2052', WOC 4 hrs. RIH, tag plug @ 1729', POH, spot 50 sx plug @ 1220'. WOC

12-02-11 RIH and tag plug @ 1048', POH to 442', pump 125 sx, circ cement to Surface, POH, LD tbg.
