12/16/11, drill 10-5/8" hole to 4046' 12/18/11. RIH & set 8-5/8" 32# J55 LTC csg @ 4046', cmt w/ 930sx (310bbl) Light PPC w/ additives, followed by 200sx (48bbl) PPC w/ additives, circ 60sx (20bbl) cmt to surf. Test BOP's to 250# low, 5000#. WOC per BLM Potash requirements.
