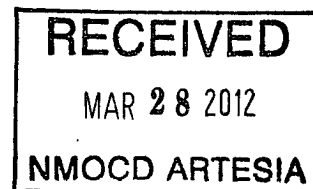

Mixed @ 14.8 #/g w/1.33 yd. Plug down @ 12:30 PM 03/10/12. Circ 76 sks cement to pit. WOC 18 hrs. Tested BOPE to 3000# & Annular to 1500#. At 7:15 AM 03/11/12, tested csg to 1500# for 30 mins, held OK. Drilled out with 8 3/4" bit.
