BOPCO L.P. respectfully requests to make the following changes listed below for the above captioned well:

Change the 4-1/2" liner to a 4-1/2" Baker Hughes completion system utilizing hydraulic set packers for zone isolation. The top of the completion system will be set with a Baker B3 packer, 75' (8,014' MD) into the 7" 26 ppf, N-80, LT&C casing shoe which will be set at 8,089' MD. The 7" casing will be cemented 500' into the 9-5/8" intermediate casing. The liner packer will be isolating the 4-1/2" casing and 20 Baker open hole packers.
