Cuttings will be discharged into steel tank.

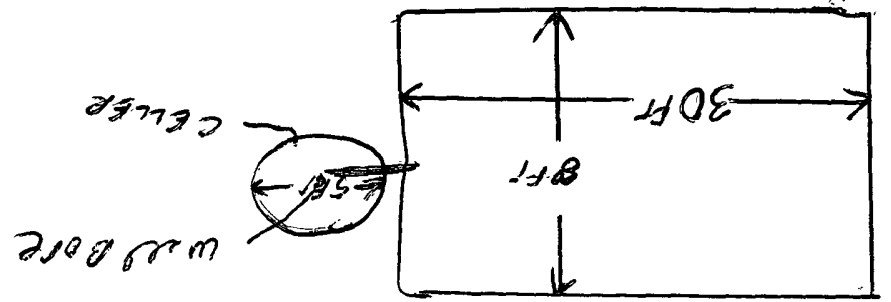
Shut down operations over night. Cuttings will settle to the bottom of the tank.

Water will then be pumped off before drilling commences the following day.

Equipment will be maintained while drilling, by the drilling personnel.

Cuttings will be hauled by JWS as needed to CRI (permit number R9166).
