8/15/11: Pump 16.5 bbls. 15% HCL acid w/additives.

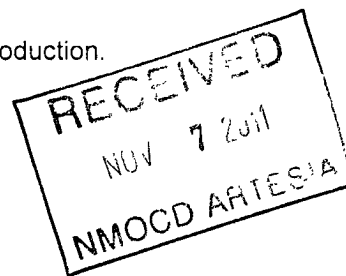
8/16/11: Pump 18.5 bbls. 15% HCL acid w/additives.
