MCKAY OIL CORPORATION proposes to re-complete the West Fork Unit #2. We wish to perforate as follows: 2834-2839', 2900-2907', 2974-2979', (2 spf) with .41 3 1/8" gun. We will acidize with 10% Fe HCL. We will frac with a 70% quality Nitrogen/CO2 binary foam with 155,000 of 16/30 sand pumping 8000# of lite prop. Swab back and Clean up well as needed and put on line.


